First, CMRC serves the community of people with disabilities and their families throughout New Hampshire and other states through three key operations. Crotched Mountain School serves students with disabilities from all over the country. The Crotched Mountain Specialty Hospital serves children and adults with brain injuries, strokes, spinal cord injuries, other neurological impairments and injuries and other serious health conditions from New Hampshire and other states. Third, CMRC also serves the State and local Monadnock community through multiple specialty Outpatient Clinics that focus on people with disabilities.
